Allan Brown (KSRHT)		Full input on CAT website KIlmarnock Station Railway Heritage Trust have a wide ranging remit with one of our priorities the regeneration of the Station building itself including the refurbishment and inclusion of a training bakery, the consultation rooms, scale model shop, gamer events & yoga teachers. Original purpose of the KSRHT was to help people with a lack of self confidence, low self esteem which transitioned due to identified need into a focus on mental wellbeing and counselling. 34 Councllors operating within the facility working with those with low to moderate issues. KSRHT are not equipped or clain to be equipped to help people with more severe mental wellbeing issues. KSRHT emphasised that these services were for low level mental wellbeing issues such as low mood, panic attacks, OCD. Emphasis on the number of councillors 34 compared to NHS Ayrshire and Arran who have 8 councillors with a waiting list of 92 weeks. KSRHT waiting list is maximum of 3 weeks. KSRHT indicated that the aim of the Howard Park project was to extend the project out from the current facilities into a natural, beautiful Victorian Park which was an ideal setting for people looking to increase their mental wellbeing. KSRHT indicated that the project was not aimed at having large groups of people attending, the mental wellbeing element would be 1-2-1 appointment based with appointments lasting 45 mins. KSRHT indicated that it is in no way a service for the rehabilitation of drug or alcohol users or exoffenders. Those provisions have been delivered before at the station with no issue including the addiction recovery service which operates on the lower ground level of the station which has been operated without issue. There is no intention of relocating any of these services to the Howard Park as two rooms will be used at the back of the cafe for councelling services. Staff members at the cafe may have been through similar expereinces and would use the cafe as a soft engagement point where people can chat and e
		environment. Regeneration of the park was a priority, similar experience with the Railway station
		where, prior to the regeneration people did not feel safe within the facility to the extent where if they missed the train they would leave the station to come back later rather than waiting onsite.
		Feedback from users of the station indicates that people waiting for trains feel safer. Howard park
		project will be used as a social enterprise cafe with portion of overall profit being donated to the
		Beatson. Facility will be a safe place for people to sit and have coffee, enjoy the suroundings, have access to toilets for park users, parents to monitor thier kids using the play park

		I note the attached (to your invite) contents of the accompanying response from the Trust and that they absolutely refute specific concerns previously raised.
		Those being that no rehabilitation services for offenders or people with addiction issues would be provided within that public family amenity setting.
		I would appreciate in my absence if you would be able to raise for discussion my simple expectation:
		1. That the documented terms of any public asset transfer in this case specified these types of services would be permanently excluded.
		2. Any future attempt to introduce them by any party (assuming such a transfer proceeds) would be a clear breach of those terms resulting in the immediate return of the asset to Council ownership.
		I do not consider this expectation unreasonable, nor should the Trust, as it provides reassurance to surrounding local residents whose children and grandchildren use the park on a daily basis.
		From my perspective, on behalf of my family, that specific undertaking as a matter of public record would remove any need for future legal civil action against the Council Members or the Trustees involved.

Craig Fulton (EAC)	Response	Community Asset Transfers have a number of legal assurances given that the assessment on the Asset Transfer are based on community benefit. This means that a change in the purpose of the organisation outwith those that the organisation are assessed upon may mean a breach of the lease. While these protections are built in to the lease I will pass over to you Allan to respond.
Allan Brown (KSRHT)	Response	We would have no issue of inserting a clause with these terms within the lease if the asset transfer were to progress given that it was not or ever had been the intention to move these services into the Howard Park.
	Objection	East Ayrshire employees should not be sitting with the trustees of KSRHT and also indicated that objections recieved prior to the meeting should not have been discussed with the KSRHT. The set up of the meeting clearly indicates that KSRHT and East Ayrshire Council are already aligned with future plans.
Craig Fulton (EAC)	Response	The meeting will be chaired fairly and independantly no matter the seating arrangement. East Ayrshire Council have given support to KSRHT throughout the asset transfer process as is the Councils approach with all asset transfers.
	Response	the set up with EAC sitting being between KSRHT Trustees indicated an allignment with the future direction of the project prior to any objections being rasied. Did EAC send the responses out (confirmed) to the objections which had no indication of the number of objections which had been raised in the first instance.
Craig Fulton (EAC)	Response	All objections are held online and are able to be accessed as per the agreed terms of the Community Empowerment Act 2015 given that this is an area of Common Good Land. The meeting has only begun with one representation recieved and addressed in the absence of the objector. Surely it would only be fair to allow objections to be rasied first of all and allow those to be addressed rather than making assumptions about the alignment of the council with KSRHT?
Craig Fulton (EAC)	Question Response	Has the asset transfer to the KSRHT had already taken place. No this has not been approved and all asset transfers of buildings have to be presented to EAC Cabinet. An asset transfer includes the submission of stage 2 application, financial documents, business plan and the community consultation. Once the consultation had finshed it would then be up to the KSRHT to submit their documentation for assessment.

Craig Fulton (EAC)	Question Response	It should be noted that there are provisions for the exclusion of press and public in some circumstances and that access to Cabinet may be restricted due to ongoing coronavirus protocols. What will the future of the building would be if the Asset Transfer does not go ahead. There is no defined outcome for the building however it is recognied that it is in a poor state of repair. The condition of the building would traditionally not be suitable for Community Asset Transfer however the KSRHT have indicated that they believe the location and history of the building makes it an asset and have pursued as such.

		the work completed onsite is completed by volunteers. Other work including the counselling services are confidential and operate under a no stigma approach therefore there is not any labelling above
		the doors to ensure this approach is successfull. This ensures that while the rooms may not be open
		to the public they are well used for the charitable aims of the KSRHT.

		as indicated previously by (KSRHT), the trust is not geared up to deal with the complex cases. What

		may have suicidal thoughts.

		from the property, graffeti on garage. People will linger at the cafe, leaving (cigarette) butts, increasing the amount of broken glass, more noise. This is the right thing to do and I would agree
		that it is needed but that it was in the wrong place.
	Response	I work with people with mental health issues every day, the idea that thoughts of suicide mean that
		people had severe mental health issues is inaccuarte. The idea that because someone had mental
		wellbeing issues they are not more likely to vandalise or graffetii.
Allan Brown (KSRHT)	Response	(Address initial objection) I have sympathy for the challenges that the you have had (in terms of the
		ASB etc) and am sorry that fear was spread throughout the community in terms of Anti-Social
		Behaviour. Through the expereince of the KSRHT with (Railway station) is the exact opposite as
		buildings become occupied, manned and well lit that the Anti Social Behaviour reduces. Vacant
		buildings where people are not around to see what is going on is when ASB occurs.

Allan Brown (KSRHT)	Response	What is your worst case scenario? It gives the impression that people with mental wellbeing issues are a risk to others but that evidence shows they are more of a risk to themselves and this project is
Not declared 5.	Response	aimed at helping them and getting help within their own community which they are entiltled to. Will those using the facilities have a pyschological assessment (at the Raiway Station) before being pushed down (Howard Park) ?
Allan Brown (KSRHT)	Response	The programme is not about pushing people with mental wellbeing issues anywhere. Those that engage with the programme have been assessed by Mental Health professionals, practitioners, Gps that refer cases to the Trust so people are assessed initially to ensure that they fit within the bracket (low to moderate issues) that the Trust are able to deal with. The Trust dont accept referrals for anyone that has severe mental health issues and dont tend to get them because the mental health practioners and GPs know that that is not an answer for people and they have to refferred onto a psychologist or psychatrist or another appropriate service. I would emphasise the previous point about the cafe being a standard social enterprise which will encourage footfall into the park and provide a service to people within the environment as it will be well lit and complys to Scottish Government initiaitives to have places well lit so women can feel safe when they are running, jogging or walking or people are out walking their dogs. This is about helping people within the park feel safer not about bringing a service to the park and pretending its a cafe.

Allan Brown (KSRHT)	Response	
	Response	Café will provide a soft engagement point. Trust have expereinenced that the referrals that are received from self referrals 44% have no contact with statutory services as they fear presenting with a mental wellbeing issue will have an ongoing effect and implications to them and their families. So if they have children they may end up with social work involvement. The cafe is more an opportunity for people to see that there are non judgemental help and opportunities offered, the fact that they have the rooms at the back doesnt mean that people will be moved to the back to be dealt with it is more about the promotional aspect offering support to those with wellbeing issues.
Not declared 6.	Response	Will the entrance to the wellbeing rooms be from Mews lane with the entrance to the café being from the front of the facility? How do these two things marry up?
Allan Brown (KSRHT)	Response	The café gives an opportunity to publicisie that there is support for those with mild to moderate wellbeing issues pointing people to the website where requests for support are triaged. It would not be a case of people turning up to the café then being led through to the back of the facility. There is a process where the referral is made, an assessment on the support required, an appointment made seperateley then people would use the rooms on a seperate basis.

Craig Fulton (EAC)	Response	We have to be very clear here that objections have to be based on the community benefit of the actual proposal and we have to also be very clear that any propsed limiting of opportunities to people with mental wellbeing issues cannot be accepted. Objections on these grounds are not suitable as it is against the equalities act. Would ask people to be very careful with this.
	Question	Would like to know if there is a risk assessment carried out for what is planned in relation to the people who will be attending and the fact that the facility will be directly opposite the childrens swing park. I have some experience with people with mental health issues and understand that it is wide and varied as <b>Company of the standard sectors</b> so would like to know if there are proper risk
Allan Brown (KSRHT)	Response	assessments in place. Initial triage completed by mental health professionals before they are referred to the Trust. A further assessment is carried out by qualified councillors. We don't take anyone that is referred to us we go through a strong process.

Allan Brown (KSRHT)	Response	Looking at those aspects I would appreciate if you could paint me a picture of your vision, it seems that you believe that there will be a threat to individuals if there is someone who presents with a

Someone who is troubled for whatever reason can become volatile quite quickly, children playing in the park would have no comprehension of that so if they are in direct communication in someway it is possible that there could be trouble and I think that is where we need to be very clear, has it been
Allan Brown (KSRHT)	Response	assessed properly. I would answer yes as we carry out risk assessments as an ongoing process with individuals and that includes from triage all the way through any of the interaction we have with them on a constant basis. Its about assessing mood, safety plans and risk assessments as appropriate.
Allan Brown (KSRHT)	Question Response	So have they been done the risk assessments? Yes we do this on a daily basis here and that would be applied at the park as well, we are well governed and we carry out every process that we need to. This perception that there is some kind of risk involved with someone with mental health issues attending the park is false. There is risk with anyone entering the park who isnt engaging our service and is just a member of the public that is also there. We carry out the risk assessments and have the governance we need to fulfill our obligation with the Health and Social Care Partnership and that is deemed as an appropriate level so I would answer yes to that.

Objection	I would say that there is a lot of positives to what you are planning to do but my concerns are that as a local resident I have spoken to the community police on a number of occasions in terms of the vandalism and the fires which have been set and I know for a fact that the Police are very stretched and my concern is the fact that this social enterprise in the park, given there is already a stretch with the Police from the young ones how are we going to police more people, more crowds coming to the park. Is there set timescales when it will be opening and closing, is it going to be open late which would mean more policing, more safety, more cameras into the area? Right now none of the residents feel safe and the Police are really struggling to keep on top of it and I feel that with these teenagers coming into the park will leave police more stretched and (KSRHT) as the scapegoat so
Allan Brown (KSRHT)	Response	there would need to be liaison with the Police in the local area. This is something that we do on a regular basis in particular with the transport police being based in the station and we have involvement with the Community Police as well. When it comes up to these kind of issues then these are police matters. We would operate as we do in the station if there is someone who is acting inappropriately or if there is anything being done which is inappropriate then we would address this in the correct manner we dont tolerate it, when its manged well its governed well. We are open to the members of the public for the cafe and there is people who do come in that will ask about what we do there is members of the public wander in and we deal with that in the right way. I understand your concern however from our perspective (cafe) is not going to encourage that type of behaviour and it is more likely to discourage this behaviour. Project is about building positivity, showing that we are proud of the park we have got and that we are going to use the park, that we can use the cafe and its not a case of the parks deserted to let people roam free and do whatever they like and carry out anti-social behaviour I understand where you are coming from and the perspective for everyone.

Objection	I don't know if you have been to the park but its not deserted because the locals use it regularly, its not deserted it's a case that it is not policed and I feel if we are putting an enterprise as you say in the middle of it its going to encourage more people and rightfully so, but we dont have the resources and the infrastructure to protect the locals then its just a recipe for disaster as your encouraging more crowds and the wrong crowds with young people especially at holidays thats my concern. Allan Brown (KSRHT) Not Declared 10.	Response	We would operate during normal day time hours, core hours of 9am-5pm effectively. Its not something that we would envisage happening late at night. It would only be the case if it was small groups, I gave an example of the family history group if they were to use the rooms at the back then it would be a secure entrance. We normally set up our own CCTV as protective measures. Will the toilets stay open at night time?
Allan Brown (KSRHT)	Response	No the toilets would remain closed as these need to be managed and supervised and we understand that responsibility as that is something we had to take on (at railway station). We have a responsibility when your operating facilities to the members of the public and sometimes this isnt going to be in a positive fashion.

Allan Brown (KSRHT)	Response	It would be preferable to light the whole park in terms of safety however the Railway Trust are trying their best as a small organisation which would take a step towards hopefully building the community spirit, harnessing the positive aspects of the park and work toghether to get a good solution for the community and help with the Town Centre Regeneration. There is a cost involved if we were to light the whole park but it is about trying to make a small step which will smowball and help generate more interest

If the council were to endorse this and let this go ahead do you have plans to invest in the park and make it a safer place? In the last 6 months the vandalism and the crowds have got a lot worse, we have fires and glass which is ridicoluous. What is East Ayrshire Council going to do to help the area as well as this venture.

From a Council perspective we deploy our Youth Action Team which is a number of staff members who go to areas of hotspot for the antisocail behaviour. I will find out if Howard Park has been highlighted as a hotspot and if that is the case then we will deploy our resources there. The Youth Action Team engage with the young people attempt to displace them or divert them to areas which are better lit, more populated and are less likely to encourage problematic anti social behaviour. I live near the park and was walking my dog to be faced by 20 youths drinking and this girl at 15/16 years old trying to push a bin over with her friends egging her on and that is what we are up against and its really quite intimidating. If you are going to bring people in who have mental health issues is that really the kind of environment that we should be bringing them into?

We will take up the issue of ASB and discuss with the Young People, Sport and Diversion manager and we will see if we can get some support in at the times that are most pertinant to Anti Social Behaviour which is Friday and Saturday evenings and that is when our youth action team operate. "Youth Action Team have had a strong presence within the Howard Park since the start of the year attending regularly on a Friday and Saturday. Howard Park will remain a prioirity while it is defined as a hotspot. Resources are however finite so if the need is greater elsewhere then the resources will be diverted to the areas with the highest incidences of ASB. "

discrimination against (mental health) my concern is for the safety of the service users as well and if your going into the park and a 17 year old girl or boy sees you going into this cafe for this purpose, and its a great service I dont dismiss that for a minute but going into the park and you have those 20 youths who say "we know you, your in 5th year at the Grange whit you going in there for are you a bit..." your going to get all that sort of scenario.

Facebook that parents should not allow their children to congregate in parks due to the anti social behaviour and violence. People have been assulted in the park through no fault of their own, people roundabout are scared to walk their dogs as well. I wouldnt access the park to walk to the Galleon if it beyond daylight hours or even in the winter after 4pm when its dark. I drive my car their rather than walking through the park and it really is a concern for safety for the park. This is nothing against your service, my concern is that the safety of the park and the risk further to people who are accessing these services.

Its not a case of forcing people to go to that particular location or the cafe being specifically a service in itself its only one of the avenues to engage as a soft engagement point. Its very much a non stigma approach people could be coming here to volunteer in the cafe, it could be yoga, educational class like baking its all about making people feel comfortable and giving them options to help them make their own choice where they feel safe. Again, as we are are operating during core hours and has been highlighted that most of the issues appear to be late evenings, weekends etc, we tend to be a daytime operation so its about lessening the risk. Having the option in the park allows us to give the options for people to choose whatever suits them and thats what we put at the forefront is what suits the individual first. For a lot of people that is to come here which is an indication of why we are as busy as we are.

This place is public, people can go to the train and noone would knows why they are here but this café its publicised that these services are available then it gives an opportunity for the small minority of the population to act that way towards individuals.

Primarily this will be a social enterprise where people visit but they can also get the opportunity to discretley tap into a service if they require it. Now that happens throughout the town centre, it might be leaflets, it might be someone discussing or word of mouth in fact 23% of our referrals are because of recommendation. Its not about presenting the cafe as a service its a soft engagement point where people can feel safe to access services. The primary aim is to provide a cafe in the park and to provide the amenity that people can enjoy and hopefully get rid of some of this antisocial behaviour and make it a positive place for people to visit.

Allan Brown (KSRHT)	Response	(lighting?) meets the legal requirement, but for what is it for the amount of traffic or is it for personal safety and thats my arguement that I am having with the Council which I dont have an answer for. So I am looking at it from people who are using the facility as well as your staff. It is something that we can give some consideration to.
